COMPETITION NOTICE FOR THE PROVISION OF A SPECIAL SUBSIDY A.Y. 2023/2024 USEFUL INFORMATION

WHO CAN APPLY FOR THE SPECIAL SUBSIDY:

Italian and foreign students in situations of exceptional economic and/or social hardship regularly enrolled in the academic courses indicated in the announcement.

The special subsidy is incompatible with other scholarships.

WHAT ARE THE REQUIREMENTS:

- Regular enrolment in the current academic year at the time of application;
- Situations of particular economic, familiar and/or personal hardship, due to facts or events indicated in the notice, appropriately documented and occurring after 01/01/2023 (but before the notice's date of publication);
- ISEE less than or equal to 30.000,00€, ISPE less than or equal to 62.500,00€;
- Achievement of at least of ten credits in the previous academic year (only for those enrolled in a year following the first).

DOCUMENTATION TO BE SUBMITTED:

- All students with assets and income generated in Italy must be in possession of the ISEE certificate or receipt of the DSU specifically for "Benefits for the right to university study";
- Current ISEE (only for situations of serious and unforeseeable worsening of the student's economic, familiar or personal conditions);
- Original documentation useful for the calculation of the ISEEU/ISPEU parificato (only for foreign students and in the form described in the application notice);
- Identification document (only for those who log in with "Weak Authentication" credentials);
- Documentation attesting to the situation of economic, social and personal hardship.

AMOUNT OF THE SUBSIDY:

- The total amount of funds available for the special subsidy for the A.Y. 2023/2024 is set at € 30,740.00; The amount of the subsidy for each application will be re-proportioned according to the number of applications deemed eligible, until funds are exhausted;
- The maximum amount of the special subsidy is € 1,500.00 per student;
- For students enrolled in part-time study, the amount will be paid at the rate of 50%;
- Payments can only be received by crediting a prepaid card or bank/postal account, with an IBAN code in the student's name or joint name.

TERMS AND PROCEDURES FOR SUBMITTING THE APPLICATION:

The application for the special subsidy, for the academic year 2023/2024, must be submitted by logging in the [Reserved Area](#) on the ERDIS website,

starting from the 4th of March 2024 at 18:00

and

ending by the sixtieth day from the notice's publication date.

It will be necessary to log in on the ERDIS website through the STRONG authentication system (or through access with credentials, in case of international students without an Italian identification document who do not reside in Italy and/or underage students), after which you can fill in the online application "Extraordinary subsidies A.Y. 2023/2024", accessible from the "Applications for services" section.

Once the application has been confirmed, it must be integrated with the required documentation, by accessing the "Upload documents" area.
